conviction may be aggregated to determine a single adjusted offense level--was mandatory. *Id.* at 528. Nevertheless, the defendant in *Parker* had not raised the issue of aggregation on appeal and had failed to object to the sentencing court's calculation. *Id.* at 529. We thus applied the plain error standard of review. *Id.* at 529-30; see also *United States v. Neal*, 92 F.3d 595, 602-03 (4th Cir.1996) (plain error standard applied when defendant failed to object to conduct relevant to the guidelines). 50 In *United States v. Ewing*, 957 F.2d 115, 116-17 (4th Cir.1992), we decided that the district court had erred in its computation of the aggregate sentence in light of a series of earlier convictions. In addition to reversing the sentence,

however, we held that the defendant's failure to raise the issue on appeal constituted a waiver. *Id.* at 116. 51 In another sentencing case, *United States v. Knorr*, 942 F.2d 1217 (7th Cir.1991), we held that, although the trial judge had committed certain sentencing errors, the defendant's sentence was not reversible because the errors were harmless. *Knorr*, 942 F.2d at 1222. We stated: 52 We agree with the government that [the defendant's] three drug convictions, which were consolidated for sentencing and which were vacated by the district court, should not be counted in determining the base offense level for sentencing purposes because they were "related."
